## Frequently Asked Questions

Q: What do I need to bring to the intake?

A: Your most recent court order.

## Q: What does the program cost?

A: Fees range from \$10 to \$50 every three months, based on a generous sliding fee scale. Scholarship opportunities are available.

# **Q: How long can I participate in the program?**

A: Up to one year.

## Q: Is parent education required?

A: We require the non-custodial party to attend the Flexible Families: Parenting Through Separation or Divorce class within the first three months. We also encourage the custodial party to attend this class at a separate time.

## Q: Can I bring food to visits?

A: Unless there is an exception in the court order, we permit peanut-free food and drinks within the center and a kitchenette is available for basic preparation needs.

## **Nurturing Connections** Supervised Visitation Program

Our **Nurturing Connections Supervised Visitation Program** provides on-site supervised visitation at the PRC on Wednesdays and Saturdays for enrolled families. During these visits, the center is closed to the public and families have private use of the space.

The Nurturing Connections staff are specially trained to encourage positive parent-child interaction, provide informal parent education, and facilitate the growth of family relationships.

The center's space provides a welcoming atmosphere for adults and young children. Toys, crafts, and special areas for reading, writing and STEM activities promote positive, playful relationships. Comfortable adult seating and free coffee are also available to families.

Participating families also receive free parent education classes to help nurture their parent-child relationship.

> Note: Intakes need to be completed and a court order needs to be on file before visits can begin.

## 1. Complete an intake at the PRC
